- MISSION** Miracles for Kids is a non-profit organization based in Orange County, California. Our mission is to improve the lives of children with cancer and other life-threatening illnesses.
- OBJECTIVES**
- (1) To effect immediate change by operating programs that assist critically-ill children and their families with daily emotional and financial struggles.
 - (2) To effect long-term change by funding cutting-edge research to find a cure for pediatric cancer.
 - (3) To serve as an advocate and resource in the community for critically-ill children and their families.
- IMPACT** Miracles for Kids creates stability at a time when families are crumbling from the emotional and financial impact of fighting for their child's life.
- PROGRAMS**
- Grant Program:** Provides direct financial support to low-income families who, as a result of their critically-ill child, are struggling to fulfill basic financial obligations such as rent/mortgage, food, transportation and medicine.
- Basket of Miracles Program:** Delivers fresh food, household items, basic necessities and seasonal gifts to program families throughout the year.
- Fund-a-Family Program:** Matches individual families in crisis with donors interested in providing one-on-one support.
- FamilyCare Program:** In partnership with Personalcare Physicians, provides high-end healthcare to uninsured members of a patient's family.
- Miracles Surf & Paddle Camp:** Provides critically-ill children the chance to experience surfing and standup paddle activities under the guidance of expert instructors.
- BENEFICIARIES** Low-income families with critically-ill children under the age of 21 who are in treatment at CHOC Children's Hospital.
- HISTORY** Miracles for Kids was founded in 1998 as The Breeze Fund, an internal fundraising effort of a local mortgage company with the purpose of raising funds to support the research efforts of the Pediatric Cancer Research Foundation (PCRF). The Breeze Fund was successful in raising significant funds for PCRF, but the firm's owners felt a greater impact could be made by creating an independent 501(c)(3) organization and broadening its fundraising efforts. As a result, in 2002, Mortgage Miracles for Kids, known today as Miracles for Kids – was created.
